INTRODUCTION:

The Lie that Took the World

The lie that power, wealth, and divine favor belong only to one class, one race, one empire.

In 1493, a papal bull (letter), named Inter Caetera was issued by Pope Alexander VI. It stated that any lands not already claimed by a Christian ruler could be seized, subdued, and brought under European rule—and that non-Christian peoples had no rights to sovereignty or ownership.

This was the divine permission slip for genocide, land theft, and cultural erasure.

It birthed white supremacy as we know it: not simply as hatred or bias, but as a global operating system that governs wealth, land, resources, and even the way we view ourselves.

Since that moment, the world has been shaped by a **four-stage process of domination**:

- Establishment The idea was born:
 Christian/European equals superior. Indigenous and Black people were devalued from the start.
- Maintenance This notion was enforced through slavery, segregation, land dispossession, and systematic violence.
- 3. **Expansion** The doctrine spread globally through colonization, capitalism, and perpetual conflict.
- 4. **Refinement** In our modern era, these legacies are even more insidious—operating subtly through credit systems, zoning laws, property values, and cultural narratives.



If you are Black, Indigenous, or a person of color, you were likely born into this system with no explanation, only expectation — to work twice as hard, to prove your worth, to struggle for scraps, and to feel shame for what was stolen from you.

This book exists to break that silence.

It exists to reveal the architecture of a lie, so you can finally begin to dismantle it — in your thoughts, your choices, your family, your land, and your future.

Because your legacy was never truly lost — it was hidden, renamed, and resold. But it is still yours.

This is not just history. It is now.

And you are the balance the world was always meant to have.

Some things were stolen in silence.

The Receipts: 3 Papal Bulls That Changed the World

These documents weren't just decrees. They were war strategies cloaked in religious authority — used to justify centuries of colonization, genocide, and cultural erasure.

Authorized the king of Portugal to "invade, search out, capture, vanquish, and subdue all Saracens and pagans" — and reduce them to perpetual slavery.

2. Romanus Pontifex (1455)

Granted Portugal exclusive rights to conquest and trade along Africa's coasts, sanctifying the enslavement and economic pillaging of non-Christians.

3. Inter Caetera (1493)

Split the "New World" between Spain and Portugal after Columbus' voyage. It stated that lands not inhabited by Christians were available to be claimed — a global death sentence disguised as a divine right.

What the Court decided:

📕 Johnson v. M'Intosh (1823)

This U.S. Supreme Court case is one of the most important legal decisions *you probably never learned about.*

It laid the groundwork for stripping Indigenous people of land while making it look lawful.

Here's the core issue:

Two white men both claimed ownership to the same land. One had bought the land directly from a Native tribe. The other got a land grant from the U.S. government.

The Supreme Court sided with the one who bought from the U.S. government.




Why?

Because Chief Justice John Marshall ruled that **Indigenous tribes didn't have the right to sell their land.** According to the court, they only had a "right of occupancy" — not true ownership — because the land was "discovered" by Europeans.

In other words:

The land belonged to whoever discovered it. And Indigenous people didn't count.

This ruling made it *illegal* for Native peoples to sell, own, or control land — unless the U.S. government allowed it. And because the U.S. based its legal doctrine on European "discovery," the theft was globalized.

🚫 Manifest Destiny & The Enclosure of the World

In the 1800s, Manifest Destiny — the belief that the U.S. was destined by God to control the land from coast to coast — gave white settlers a moral excuse to steal.

Add to that the **British Enclosure Acts**, which privatized communal land across England and forced the poor into wage labor, and you have a global formula:

- Declare land "empty" or "misused"
- · Criminalize the people already living there
- · Legalize their removal
- Profit from their loss






★ The Global Pattern

🔽 The Co-Opting of Poor Whites

One of the most insidious moves of the refinement phase was convincing poor and working-class white people that their alignment was with the elite - not with the oppressed.

They were given just enough access:

- · Legal rights denied to others
- Jobs on top of Black labor
- The illusion of "superiority" in exchange for loyalty

They forfeited their lands.

They suppressed their wages.

They broke their unions.

All to align with the powerful class (white supremacy) as a tool to support the theft, dominance, and mistreatment of non-whites (blacks).

This is why white supremacy continues. Because it disguises theft with race - and uses it as bait.



Who Are the Refiners Today?
